**IMPORTANT INFORMATION ABOUT YOUR DUES**

Members of MSC are automatically members of MYCA (Our Non-Profit Governmental Relations Organization). Your total dues will be divided between MSC & MYCA as follows:

- 53% of dues go to MSC. This amount is deductible for federal tax purposes.
- 47% of dues go to MYCA (Non-Profit Governmental Relations Organization). Some of this amount may be deductible. However, the part used for lobbying activities is not. A year-end statement will be sent to you showing the amount of non-deductible lobbying expenses.
