With the recognition and understanding that each camp is unique, Emily and Nick's goal is to help you lead with confidence while reducing stress and building a culture that can actually withstand the emotional load of a real summer season at your specific program. After this interactive workshop, you'll have

MYCA UPDATE

PRESIDENT'S MESSAGE

In response to the Camp Mystic tragedy this past summer, the Texas legislature passed emergency House Bill 1 (Youth Camper Act) and Senate Bill 1 (Heaven's 27 Camp Safety Act) mandating stricter regulations for TX youth camps' emergency preparedness, staff training, communications and inspections. The draft of the newly proposed rule was released this week,



with formal adoption expected to take place early in 2026. Several other states have proposed camper safety legislation, also in response to the tragedy. At this time, no legislation specifically related to camper safety has been submitted for Maine's second session of the 132nd legislature, which will reconvene in January.

Maine licensed youth camps have been regulated since 1974 through the Maine Department of Health and Human Services (DHHS). Our rule, commonly known as the "Youth Camps Rule" or "Chapter 208", was recently updated after an 18-month stakeholder process involving DHHS, MYCA and individual camps. The rule was promulgated in May 2025, and camps were inspected by the Health Inspector Program (HIP) this past summer under this newly updated rule. Section 13. A. and B. (pg. 40) list the requirements for licensed youth camps in Maine regarding risk management and emergency procedures in the event of a disaster:

SECTION 13. SAFETY PLANS AND DISASTER PREVENTION

A. Administration of Disaster Safety Plans, Drills and Protocols.

- 1. The operator must have an emergency plan in place that addresses communication protocol and response to possible disasters, such as fire, weather, and other potentially lifethreatening events, such as injured or missing campers or intruders or trespassers at the camp. Critical
- 2. Emergency communication protocols must specify an appropriate mode of communication for the situation or event and locale, and address coordination between trained responders, camp staff and affected individuals. Critical
- 3. Emergency response protocols must include active shooter emergency response protocols. Critical
- 4. The operator or designee must instruct campers and staff in these procedures and must conduct and document at least one drill during each camp session. The type of drill is determined by the camp director or designee. Critical

B. Emergency Disaster Prevention Plans

- 1. The operator or designee must maintain a copy of this emergency/disaster prevention plan at the camp office. Critical
- 2. The written policy must direct that each camper may only be released from camp into the custody of a designated person,

previously identified in writing, who may include the camper's parent, guardian, or other person(s) specifically identified by the parent or guardian. Critical

As mentioned in the previous MSC NEWS, MYCA is busy preparing membership resources and/or webinars for important topics:

- When is an **Eating & Lodging license** needed for your camp?
- What is a camp **immunization policy** and when should parents access it?
- What should you do when your camp has a bat-in-a-cabin/building incident?
- Maine Board of Nursing rulemaking for Unlicensed Assistive Personnel (UAP) clarifying medication administration at camp

MYCA Governmental Affairs attorney, Newell Augur, continues to monitor labor bills in Augusta which were carried over to the 2026 legislative session and may affect youth camps, including:

- LD 54: An Act to Require Employers to Disclose Pay Ranges and Maintain Records of Employees' Pay Histories
- LD 60: An Act to Allow Employees to Request Flexible Work Schedules
- LD 599: An Act to Raise the Salary Threshold for Overtime Pay
- LD 799: An Act to Report Gender Wage Gaps
- LD 61: An Act to Regulate Employer Surveillance to Protect Workers

MYCA will continue to follow these bills and will update membership.

aine Summer Camps has offered Casual Conversations on a variety of important topics in the last few years. One of the most well attended was a conversation on having difficult conversations during staff training in preparation for summer. We have learned over time that casual conversations resonate as they are less structured than a workshop or webinar, yet more structured than some of the informal roundtables and groups that camp pros independently participate in by choice and/or by invitation with peer camps, cohorts and the like.

The point of offering MSC's Casual Conversations is to keep it casual and conversational with a relatively open agenda — all while providing opportunities to listen to differing points of view, to identify relevant best practices, to gather pro tips, and to converse with camp pros who may not be in your regular orbit.


We have decided to host Casual Conversations more frequently and on a regular basis — roughly once a month. They could

happen more frequently, depending on how and why topics are identified. As the calendars of camp pros are super crowded, it will take a minute to identify the regular day of the month and the best time of day for this new, regular offering. In the meantime, we will experiment!

We have held two Casual Conversations at this point: November's on **DEI Challenges and Successes** from Summer 2024, hosted by the DEI Committee on a Monday afternoon and December's **Everything Needs to Happen Earlier: International staffing best practices for camps this winter.** This was facilitated on a Wednesday morning by Staffing Committee Chair Dave Schiff and Lucy and joined by several Business Members operating in the International Staffing space.

MAINE SUMMER CAMPS PROFILE

There is no question that Maine camp professionals utilize a vast quantity of talents and skills in their work serving youngsters attending camp across the state. But many of these same professionals share their abilities in other settings as well. In each upcoming newsletter, MSC will feature camp pros who are investing their time in projects outside camp. This issue we profile Fernwood Cove's **Beigette Gill**, who serves as an advisor for the Olympia Snow Women's Leadership Institute.



Beigette Gill: Sharing her Passion and Expertise in the Olympia Snow Women's Leadership Institute

eigette Gill certainly knows about girls and their journeys. Fernwood Cove, the camp in Harrison that Beigette owns and directs with her husband, Jim, provides hundreds of girls each summer with the opportunity for connection, challenge and personal growth. Now Beigette is also sharing her passion for and commitment to high school girls' development by guiding participants in the Olympia Snow Women's Leadership Institute.

The Institute, serving high school girls since 2015, was founded by former Maine Senator Olympia Snowe "to raise the confidence and aspirations of high school girls by helping them develop the skills needed to be leaders in their lives, families, careers, and communities." This mission statement is complemented by the program's vision to be a national model for enabling high school girls to "recognize their gifts" and become future leaders. The leadership institute program is divided into three themes. In tenth grade the girls explore "My Values," followed by "My Voice" in 11th grade and "My Vision" in their senior year.

It's right up Beigette's alley.

Along with a "Co-OLA" (Olympia Leader Advisor), Beigette began working with a group of high sophomores during the 2024-25 academic year at Mountain Valley High School in Rumford. The co-advisors meet monthly with the same six girls and will follow them through their senior year.

Beigette's involvement was spurred by happenstance about five years ago, she says. "My car was getting repaired at Moody's in Auburn and on the coffee table was a newsletter about Olympia Snowe's Women's Leadership Institute. I picked it up and what stood out was the core curriculum of the program." The three themes of the program "were so well put together," Beigette said.

"How integral I thought that would be for the girls who are in high school and figuring life out and what direction to go and who they are."

At that time, Beigette says, she didn't have the time to dedicate to the program but "years later, I looked more seriously."

At its outset, the program served 45 girls in seven schools serving Androscoggin County. Today, the Institute's website states, nearly 600 girls in 38 schools — across all of Maine's 16 counties — participate in the program.

Beigette says her camp work and her role as an OLA have a reciprocal relationship, "which I love." Her vast skillset facilitating conversations among groups of different sizes comes into play, as does her expertise teaching smaller groups in activities at camp.

"I feel like all of those experiences help me be present and bring listening skills to the table," she said.

Beigette says that the curriculum, which has been in use for nearly 11 years, is "very well developed." Each month the OLAs receive a facilitated guide, and Beigette meets with her Co-OLA to decide what sections each will handle. "They also provide a Zoom prior to the monthly meeting to go over the curriculum."

The OLAs include women from various career paths as well as women who have retired, Beigette says. Teachers nominate students, known as "OLs," who they believe will both benefit from and add to the program, she says. Students make a three-year commitment to the program and can earn both academic badges and university credit.

At the leadership institute's annual Fall Forum, which was held in Bangor this fall (on the same day as the Migis Meet-Up!), all the OLs in the program gathered with OLAs for an event that "spearheads the year ahead." It included conversations about careers, networking, and navigating job searches, including the opportunity to practice interviewing techniques, Beigette says.

"What I love about it is it's truly working on introspective skills," Beigette said.

"It's a gift [to OLs] to explore themselves, recognize that people are there to support them, and have an institute to be connected to," Beigette says. "Once an Olympia Leader always an Olympia Leader.

And it's a gift to six of those OLs to work with Beigette Gill.

Maine Camp History

Maine Summer Camps Support the War Effort: 1942

According to a newsletter article published by **Camp Wohelo** in 1942:

"All the camps of Maine are co-operating to raise money for the Red Cross. The total amount raised will be sent to the Treasurer of the Maine Camp Directors' Association in a lump sum at the end of the summer."

As further stated in the article published by Camp Wohelo in 1942:

"We have high hopes in regard to the amount we will beable to raise. Each camp will try to do its part to help this worthwhile co-operative venture. Through the Red Cross Life Saving Program, the camps have been assisted for many years."

In the context of this Camp Wohelo article, Maine Summer Camps have been grateful to the Red Cross for assisting in water safety and lifesaving programs. Raising money for the war effort gave Maine Summer Camps an opportunity to give back.

The efforts to raise money came in many forms. These forms included projects relating to farming as well as areas in



entertainment such as plays, dance recitals, and musicals in which the general public was provided the opportunity to pay an admission fee. It was even proposed during that time that the Sebago Wohelo girls assist a "Ferry Command" to call for parents by boat at nearby resorts as they may have difficulty in reaching camp due to the tire shortage during the war.

During the time of World War II, Camp Wohelo had been operational for some 35 years. Wohelo Camps were founded in 1907 by Charlotte Vetter Gulick and her husband Dr. Luther Halsey Gulick. Both Dr. Gulick and Charlotte believed that girls should be afforded the same or similar physical opportunities as boys and it was in 1907 when they purchased property on Sebago Lake where Camp Wohelo was founded. It is noteworthy that in 1908, the Gulicks developed camp fire for girls now known as "Camp Fire for Girls".

The tradition of Maine Camps assisting in global efforts, this historian would suggest, is generational. As stated in the Camp Wohelo newsletter in 1942:

"There is a tradition and the campers of this generation have a chance to prove that they are just as capable and original as their parents."

The spirit of giving and giving back is embedded in the Maine Camp tradition.

MSC a Benefactor Sponsor of Annual UMF Hiring Event

amp hiring season is upon us, and once again, the University of Maine Farmington will host a hiring event spotlighting staffing opportunities at MSC camps and other outdoor recreation employers. Scheduled for Wednesday, February 11 at the UMF campus, the event will include classroom visits, a panel discussion, and time to network in the North Dining Hall.

The event is almost a month earlier than it was last year. MSC Staffing Committee Chair Dave Schiff of Camp Manitou says that decision was based on feedback received after the 2025 hiring event

"The earlier we can do it in the winter the better," he said. The timing benefits camps still actively hiring as well as motivated students on campus seeking internships, seasonal, and permanent employment.

The event will prioritize opportunities for camp personnel to visit classes, as well as one-on-one networking opportunities. Austin French, UMF Director of Career Pathways & Employer Engagement, said "rather than a more traditional hiring event with tables [hosted by camps], we are trying to turn it way more into a casual networking type event."

French says the campus North Dining Hall will be set up to offer interactive opportunities, high tables to chat at, as well as camp tables around the perimeter of the room. In addition, UMF will host a career panel prior to the networking event, and "tactical class visits" will enable camp professionals to visit students in their learning environments.

"We hope UMF can serve as a hub for employers, students, and community members," French said.

Schiff praised UMF for its role in maximizing hiring opportunities.

"Only so many universities are interested in partnering in such a specific way," he said. "UMF is a really receptive community." Among UMF's qualities, he said, is its commitment to providing internship opportunities. In addition, because French also serves as project director for the university's Outdoor Recreation Hub of

Excellence, outdoor recreation students can gain exposure to longterm work experience in the camping industry as well as in other outdoor recreation fields, Schiff said.

"It's helpful to have a partner really supportive of the work we are doing," Schiff said.

Schiff said UMF professors' interest in highlighting camp employment to their students during class time is a "big, important component of what we are doing."

"When a professor is willing to say to students. '[camp employment] is going to give you a meaningful experience,' that's the best endorsement.

MSC Mentoring Project Moving Forward


irecting a camp comes with its own unique set of rewards
— and challenges. For new camp directors facing such
challenges, the support of more seasoned professionals can
be invaluable.

When Mike Douglass began directing Camp Bishopswood more than a dozen years ago, he says, "I remember that I randomly sat down with Cat (Sangster) and Peter (Kassen) at the networking extravaganza and I thought to myself, oh my gosh, they are so good at what they do. I always thought 'wouldn't it be great to have something to help new directors — or old directors — learn new things?"

Today, Douglass, along with former longtime Hidden Valley Camp directors Peter and Meg Kassen, are spearheading a Maine Summer Camps mentorship project designed to do just that.

"I see it as something that could be a really beneficial value-added thing" for new camp members joining MSC, to say we have this," Douglass said.

Although the project is in its very earliest stages, Douglass is optimistic about its potential. "Knowing MSC, my guess is if there were a bunch of mentees who really wanted to have this mentor relationship, Maine camp directors would step up."

The partnerships between mentors and mentees will take into consideration what arrangements work best for the two parties, Douglass says. "It was Peter and Meg's idea trying to not only match up but match up so that it works for both of them," he said.

Peter Kassen credits Douglass for initiating the idea. "He contacted Lucy and Meg and me and we put together a few things," Kassen said. "Sort of an introduction for mentors and mentees."

Kassen says the wisdom of colleagues is always useful. "I know when I was a director for 20 or 30 years it was good to have someone to talk to. We old-timers made use of the wisdom of our friends and colleagues." The same can be true of those "just getting started," he said. "It just seems like a great opportunity for everybody."

When Jessica Paquette took the position of executive director of West End House Camp, she had camp experience from working outside of Maine. "I had just started as executive director and I needed some veteran help," she said. Working with Douglass and Peter Kassen as mentors "was very helpful."

"I think camp professionals can be so supportive to other camp professionals," she said. When you begin collaborating with a mentor, she said, "you have that confidence that the mentor is here to mentor me."

"There's no ego involved," she said. "You can ask whatever you need to ask."

She recommends the program to others. "There are so many things that are different in the camp industry from any other," she said. Having a mentor to "walk you through and get to the heart of what camp is after 20 or 30 or 40 years in the Maine camp industry is really helpful to a newbie."

"We hope for even more this year," she said.




